HR 676, the United States National Health Insurance Act, was introduced in Congress on January 26. It is a bill to create a single-payer, publicly-financed, privately-delivered universal health care program that will cover all Americans without charging co-pays or deductibles. It guarantees access to health care services regardless of employment, ability to pay or pre-existing health conditions.

Medicare is a single-payer system. HR 676 will improve and expand Medicare so that it covers all Americans. Switching to a single-payer system will lead to billions of dollars saved in reduced administrative costs, reimbursement rate negotiations with physicians and negotiated prices for prescription drugs, medical supplies and equipment.

Rep. John Conyers (MI) is the sponsor and there are now 59 cosponsors (and the number is growing) after just one month since its introduction in Congress.

The following information came from the Association website. Did you notice Lilly Ledbetter watching President Obama's recent address to Congress? Lilly was there because she, AAUW and the Obama administration know that the fight for pay equity is far from being over. It is important that we urge the Senate to pass the Paycheck Fairness Act. The Paycheck Fairness act provides the tools necessary to give teeth to the Ledbetter bill. The Paycheck Fairness Act is "a comprehensive bill that would create strong incentives for employers to follow the law, empower women to negotiate for equal pay and strengthen federal outreach, education and enforcement efforts. The bill would also deter wage discrimination by strength-

Summary of Major Changes:

(To take affect 7-1-09 if approved at St. Louis Convention) 1. Membership Open. Membership is open to any individual supportive of the mission, without regard to college degree status, and to partner members. Partner membership broadens the current college/university membership category to include the possibility of other institutions or organizations that meet the criteria. Open individual membership provides an equal opportunity for all to join, in recognition that one does not need to have educational credentials to work for women's education. Unlimited Potential at the 16th Math/Science Conference

We did it another year! Carol K. Anderson said as we were loading up luncheon items from the Board Room, "They say it takes a village, but this Conference takes the entire AAUW membership." I am most appreciative of everyone's help before and during the 16th Math/Science Conference. It was great to see coverage in the local newspaper even though it took last minute reminding to accomplish.

There were changes on the speakers up to the evening before the event. Sergeant Diana Johnson replaced Lt. Trout for the Highway Patrol and did a great job. Cheryl Osborn needed to have surgery so Nancy Fisher, CEO of Data Distributing, also was a wonderful addition. Catherine Kirkland said she changed jobs so Anna Le Duff took her place at the very last minute.

The weather did cooperate, but the shine was off some for me because the Rio Hondo liaison didn't give the AV person any advance notice of the rooms, equipment needed, and that a PA was needed for the opening session until that morning. He did a wonderful job trying to handle equipment challenges. However, it was frustrating for him and for the speakers. I was told that all room equipment on my list would be checked the week before the Conference. I also think we could have parked in the closer Lot B after talking with security and seeing the vacancies.

I have asked the president if we can have the Conference on the Rio Hondo campus February 26, 2010. I haven't had any reply yet. I was told by Dr. Martinez this year that they might not be able to accommodate us next year because they would be having construction in the Upper Quad area. But I still asked in writing for 16 rooms in the Science Building. Anyone know any Rio Hondo Board members to contact?

I would really like to have a large auditorium for the keynote speaker so we wouldn't have to worry about rain and so there could be visual equipment. We also need rooms with quality equipment for the speakers and a cooperative facilities coordinator. I predict a few bumps with the venue for next year.

The AAUW members, students, teachers and speakers (except for audiovisual problems) have been wonderful with their positive comments. I think I only had three negative student evaluations and they were about the poor pens. Evidently since the pens were bought in bulk a few years ago, the ink has dried up inside. Anyone want to check that out? Or wash/iron aqua sashes? We had 531 students and 33 advisors from 22 schools. In addition there were 35 speakers and their colleagues helping with the presentations. We had seven members from the Covina AAUW Branch observing our Conference. One student wrote on her evaluation, "The day went very, very well."
