

#### Report from the Association Convention:

Breaking through Barriers was the theme of the 2009 Biennial AAUW convention, and that certainly proved to be true. St. Louis, Missouri is known as the "Gateway to the West" and California, was well represented with 96 delegates attending. Our voice was heard and we were there in force.

Our voice will continue to be heard, as we are well represented on the Association board. **Carolyn Garfein, a former Californian**, and keynote speaker at our CA convention, was elected the AAUW president. **Kathleen Cha** and **Alicia Hetman**, both Californians, were elected as directors-at-large, and **Krys Wulff** was appointed to the board. Congratulations to all of them.

We were treated to many exciting moments. Two of those moments were the Friday keynote speaker Lilly Ledbetter, who stayed with us through the whole convention inspiring us all, and Representative Rosa Deluaro, Democrat from Connecticut, the Saturday keynoter, who encouraged us to continue the fight for women's rights. She is known as a "hero for working families," carrying out our mission in Congress.

California was also recognized as the **#1 state in combined support**. Give yourselves a big pat on the back. Congratulations.

The business session on Saturday was exciting and intense, as the new bylaws were gone through Article by Article. **The new bylaws were passed as amended**, with a majority counted card vote. The amended portion was **Article IV**, **Membership and Dues**, **Section 2**, **Categories of Membership, a, b, and c.** The amendment was to strike this section, which was about open membership, and to reinstate the 2007 bylaws Article IV, Sections 1 through 4. This passed with a multiple card vote, Yes 865, No 564. This amendment allows further study into the question of open membership, and now gives all individual members under the "one member, one vote" new bylaws a chance to weigh in on this important issue. California's resolution was part of this discussion. Because of this amendment passing, the Association bylaw committee was given the go-ahead to make several changes in the same Article to coincide with the 2007 bylaws. Several other issues were discussed.

In Article VI, Officers and Directors, an amendment to strike seven directors-at-large, and insert ten, with three instead of six additional appointed directors-at-large, was passed. The next convention will be held in 2011 in Washington, DC where we are promised to "storm the hill" again and let our voices be heard loud and clear.

Your delegates came home inspired and tired. We still had time to have our picture taken with Lilly Ledbetter as she signed an AAUW Tote Bag. The Tote Bag will be auctioned off to a lucky Whittier Branch member. Watch for the details from Brenda Jahn, President. **PAGE 2**

The 2009 AAUW Convention was held in St. Louis, Missouri. Barbara Gile, Brenda Jahn, Ginny Ball, Faye Weber, and Dolores Seidman enjoyed the events, had a wonderful time, and voted for AAUW to keep our University status for admission to AAUW!

The AAUW Whittier Branch Fund Raising Committee met Monday, July 13, 2009.

This book is autographed by Representative Jackie Speier (D-CA). Jackie represents California's 12th Congressional District. Speier began her political career in the office of Representative Leo J. While escorting defectors out, their group was ambushed by gunmen who killed Ryan and four others. Ms. Speier, then 28, was shot five times and left for dead.

## **PUBLIC POLICY**

This is my first AAUW Public Policy newsletter article, so I think it is appropriate for me to introduce myself to our membership. I joined AAUW about seven years ago after I had retired from

working for labor unions and as a teacher. For more than twenty years I have been very active working for economic justice and peace as an advocate in my church. I worked for Bread for the World as the interim Regional Organizer for one year and attended the Advocacy Days in Washington, DC. Public Policy Advocacy is a passion of mine, and very dear to my heart.

"The AAUW Public Policy Program underscores AAUW's mission of advancing equity for women and girls through advocacy, education, and research, and speaks to women's needs, aspirations, and concerns across the life span. The work of AAUW builds upon over 125 years of responsible public participation." The public policy program goes on to state several principles that provide a basis for AAUW members' actions. "Implicit in each of our principles is support for government agencies administering programs, including adequate appropriations, effective and accountable administration, and provision for citizen participation. We advocate public discussion to ensure enlightened decisions on these principles. We work to increase the number of under represented populations, including women, in policy-making, and other decision-making positions. AAUW is committed to working in partnership with diverse allies and coalitions to break through educational and economic barriers for women and girls." I will share with you only the first of those principles, and then give a suggested action pertinent to this principle.

"AAUW believes that quality education is the foundation of a democratic society. We advocate equitable and harassment-free climates, academic freedom, civic education, protection from censorship, bias-free education, and responsible funding for all levels of education, including early childhood education. We advocate increased access to higher education, especially for women in poverty. We promote equitable efforts to close the persistent achievement gap that disproportionately affects low-income children and students from minority communities."

For those with computer access please go to <u>AAUW.org</u> and click on Two-Minute Activist. You will be led through a process for sending an email to your Representative in Washington, DC regarding H.R. 2492. This legislation would prevent the taxation of federal student loan debt forgiven through the new Income-Based Repayment program. This would take the first step to ensure that students and their families who struggle with the soaring costs of college and the overwhelming burden of student loan debt aren't saddled with a new financial obligation as well.
