

GET REAL ABOUT SEX EDUCATION

AAUW supports the right of every woman to obtain medically accurate information about and access to safe and comprehensive reproductive health services. Because the United States has one of the highest rates of teen pregnancy and sexually transmitted infection in the developed world, AAUW supports comprehensive sexuality education programs that include information about both abstinence and contraception. Such programs are critical in helping to combat teen pregnancy and sexually transmitted infection.



Earlier this year, Representative. Barbara Lee (D-CA) and Senator Frank Lautenberg (D-NJ) introduced the Responsible Education About Life (REAL) Act (H.R. 1551/S. 611). This bill would authorize federal funds for states to offer comprehensive, age-appropriate and medically accurate sexual education in their schools. The REAL Act is a comprehensive approach to sex education, education that promotes abstinence but includes information about contraception. The bill would also encourage family communication about sexuality, teach young people the skills to make responsible decisions about sexuality and explore the components of a healthy relationship.

While there are currently three separate federal programs that fund abstinence-only-until-marriage programs, there remains no federal funding specifically for comprehensive sex education in schools.

The high rates of pregnancy and sexually transmitted infections in this country threaten the lives and livelihoods of women and girls. That's why AAUW joined coalition partners and promoted October as Sex Ed Month of Action. However, your action will still be needed in November. During this time, we're encouraging women on college campuses and in communities across the country to urge their representatives to support the REAL Act. AAUW believes individuals should have complete and accurate information about their reproductive health and family planning options. Only with complete reproductive health information can young people make informed and appropriate decisions that will help them lead safe, healthy lives.

VERY IMPORTANT INFORMATION

At the October Branch meeting, the general membership voted on an AAUW Affiliate Agreement required by Association. The following is a brief summary of this agreement:

(1) The big issue is that the two Internal Revenue Service (IRS) tax categories that national has had for many years will now be reversed, i.e., the dominant membership structure will be 501 (c) (3) and the secondary political action structure will be 501 (c) (4). The impact on the individual members will be that donations to the national organization and most of the national dues will be deductible on our personal income tax returns. The tax deduction on national dues currently translates to \$46. The remaining \$3 will not be tax deductible since national uses it to support the political action structure.

(2)This national change means that those branches (i.e.,affiliates) that previously had not established their own 501 (c) (3) status may now receive such exemption under the new national group tax exemption status.

(3) The change in the group status that affects our Branch does not mean, however, that local and state dues and donations to the branch will be tax exempt. In order to be a fully functioning 501 (c) (3) branch, we must apply separately to the IRS. This is important primarily if we want all donations and local dues to the Branch to be tax deductible.

(4) In line with the changes in tax categories, national will undergo several name changes. The national organization, previously known as Association, will now be called American Association of University Women, or simply AAUW. The new political action entity will be called the AAUW Action Fund and will be the 501 (c) (4) arm of AAUW. The Educational Foundation (EF) will now be the American Association of University Women, Inc. Please note that the Legal Advocacy Fund was rolled into the Educational Foundation last year.

(5) National recommends that each branch have liability insurance for its directors and officers. Our Branch has general liability insurance through AAUW California. Our Branch does not have the special "directors and officers" liability coverage at this time.

(6) The decision was made is to accept the new structure that encompasses the above changes. We signed the new affiliate agreement and submitted it to national before October 31, 2009.

century New York City, Thompson's old-fashioned mystery takes the reader from the mansions of Fifth Avenue to the flophouses of the Lower East Side. Sarah Brandt is a midwife who has been estranged from her wealthy family for years. When Alicia Van Damn, a young woman from a prominent family, is murdered, Sarah must return to the upper-class society she has scorned to find the killer. Haunted by her past and disgusted by police department corruption, Sarah takes it upon herself to avenge the girl's death. Annoyed at first by her interference, Detective Sergeant Frank Malloy asks for Sarah's help only when he has been taken off the case at the request of the victim's scandalfearing family. The midwife and the policeman grudgingly become allies in their search for justice. In this first installment in a new series of historical mysteries, Thompson vividly recreates the gas-lit world of old New York, concluding her mystery with revelations that will shock even 20th-century readers.




