#### PRESIDENT'S MESSAGE

Some time back we were asked to share our passion. So, I thought I would share mine with you. My passion has been helping develop sound leadership within those organizations with which I have been involved. In fact, while my graduate work was in Public Administration, my emphasis was in Leadership.

Throughout history we have read about great leaders and identified those deemed to be good or bad. However, *leadership* is an entirely different thing. For me leadership is not someONE leading, while others follow. No, effective leadership never creates followers. Ronald Heifetz in his book, <u>Leadership Without Easy Answers</u>, writes that effective leadership is helping in the development of those around you to achieve specific useful outcomes. "Social useful outcomes" normally do not happen by accident but rather through the "adaptive" work of the individuals involved in commonly sought outcomes--often at a personal cost. Why? Because many times leaders will be faced with the choice of putting self-interests aside rather than, as Heifetz puts it, "suppressing others' perspectives." We risk our personal biases—when and if we have the courage to face them—for that of the common good.

Not surprisingly, the result of the group's effort is that of an orchestra that while playing different instruments (skill sets and experience), all are playing one same beautiful musical piece. Vacuums are minimized and output is greater. So then, to me leadership is about bringing others along, inclusive of those in need of development and those already highly skilled, to achieve *a* common *goal* and fulfill *a mission*.

# PUBLIC POLICY AAUW POSITIONS

At our October 8 Branch Meeting, Patricia Cuocco and I will make a presentation on the 17 Ballot Propositions that will be on the November 8 California Ballot. AAUW CA has taken a position on 5 of these measures that are relevant to our issues. Nancy Mahr, Co-Chair of the Public Policy Committee of AAUW CA, details them below in excerpts from an article in California Perspective.

<u>SUPPORT 51</u> (Statute): Authorizes \$9 billion in general obligation bonds for K-12 school construction and modernization, funds for community college buildings, funds for facilities for charter schools and technical education programs. SUPPORT: adequate and equitable funding for high quality public education for all students.

<u>SUPPORT 52</u> (Statute and Constitutional Amendment): Requires two-thirds vote of Legislature to amend a current law that imposes fees on hospitals; fees are used to obtain federal matching funds for Medi-Cal. It directs fees and matching funds to uncompensated care provided by hospitals and to children's health coverage. It eliminates the law's ending date. SUPPORT: guarantee equality, individual rights and social justice for a diverse society; increased access to quality, affordable health care.

<u>SUPPORT 55</u> (Constitutional Amendment): Extends the Prop. 30 (passed by voters in 2012) income tax on high earners through 2030 – currently set to expire in 2019. This will generate \$8–11 billion per year to be used for public schools and community colleges, health care for low-income families, and local public safety. The public can track expenditures at www.trackprop30. ca.gov. This does not add new taxes, but continues taxes already in place. SUPPORT: support for a strong system of public education; access to quality, affordable health care; guarantee of equality, individual rights and social justice for a diverse society. AAUW supported Prop 30 in 2012.

<u>SUPPORT: 58</u> (Statute): Amends 1998's Prop. 227 (which requires children in public schools to be taught in English) to allow public school students who speak limited English to be taught for a defined period of time in languages other than English. Districts using this option must develop an accountability plan and involve a parent advisory committee. Parents may opt out of the program. SUPPORT: support for a strong system of public education that promotes gender fairness, equity and diversity

<u>OPPOSE 53</u> (Constitutional Amendment): Requires statewide voter approval before state may issue bonds of over \$2 billion to finance a single project. Prohibits dividing projects into segments to avoid public vote. Includes clause that if other bond measures on the ballot conflict with this measure, and both that measure and this measure pass but this measure gets more votes, then the other measure is null and void ("poison pill clause"). OPPOSE: the "poison pill" clause could nullify Proposition 51, which AAUW is supporting.

AAUW has a long and distinguished history of advancing educational and professional opportunities for women in the United States and around the globe. Here is a list of the awards. We will be hearing from some of the Fellows or Grant recipients at the AAUW Fund Fall Luncheon at the Old Ranch Country Club in Seal Beach on Sunday, October 23, 2016. **American Fellowships:** Who may apply: Women pursuing full-time study to complete dissertations, conducting postdoctoral research full time, or preparing research for publication for eight consecutive weeks.

Funding: \$6,000–\$30,000

Career Development Grants: Who may apply: Women pursuing a certificate or degree to advance their careers, change careers, or reenter the workforce and whose bachelor's degree was received at least five years before the award period.

Funding: \$2,000–\$12,000

**Community Action Grants:** Who may apply: Individuals, AAUW branches and states, and nonprofit organizations to fund innovative programs or non-degree research projects that promote education and equity for women and girls.

**Funding:** One-year grant, \$2,000-\$7,000; Two-year grant, \$5,000-\$10,000

**International Fellowships:** *Who may apply:* Women pursuing full-time graduate or postdoctoral study in the United States who are not U.S. citizens or permanent residents.

Funding: \$18,000–\$30,000

Opens: August 1
Deadline: December 1

**International Project Grants:** Who may apply: Alumnae of AAUW's International Fellowships program who are living in their home countries and pursuing community-based projects to improve the social advancement and economic empowerment of women and girls.

**Funding:** \$5,000–\$7,000

**Selected Professions Fellowships:** *Who may apply:* Women pursuing full-time study in a master's or professional degree program in which women are under-represented, including STEM, law, business, and medicine.

Funding: \$5,000-\$18,000

**Opens:** August 1 **Deadline:** January 10

Modern Trends in Literature will meet on Thursday, October 27, 7 PM, at the home of Kristine Yeseta, who will also provide refreshments. The book for October is *Burial Rites* by Hannah Kent.

A brilliant literary debut, inspired by a true story: the final days of a young woman accused of murder in Iceland in 1829.

Set against Iceland's stark landscape, Hannah Kent brings to vivid life the story of Agnes, who, charged with the brutal murder of her former master, is sent to an isolated farm to await execution.

Horrified at the prospect of housing a convicted murderer, the family at first avoids Agnes. Only Tóti, a priest Agnes has mysteriously chosen to be her spiritual guardian, seeks to understand her. But as Agnes's death looms, the farmer's wife and their daughters learn there is another side to the sensational story they've heard.

Riveting and rich with lyricism, BURIAL RITES evokes a dramatic existence in a distant time and place, and asks the question: How can one woman hope to endure when her life depends upon the stories told by others?


