PUBLIC POLICY

At the National Level:

This last summer President Elect Rozanne Child and I attended the 2017 AAUW National Convention in Washington DC. The conference included 2 1/2 days of informative workshops such as *Financial Best Practices for AAUW State and Branch Leadership*, *Global Progress and Equality for Women*, *Building Self-Esteem for Girls*, *Navigating Difficult Conversations*, *How Washington Works* and much more. Conference participants also had an opportunity to visit legislators from their home districts on Lobby Day to meet them, share with them AAUW's mission, work, issues and policy focus. We championed AAUW's research *Deeper in Debt: Women and Student Loans*, supporting women in higher education, and in advance of the 45th anniversary of Title IX, asking for adequate funding and support for the Office for Civil Rights in the Department of Education for stronger enforcement of Title IX, particularly in the area of equal pay.

One of the highlights of the conference was hearing and meeting Associate Supreme Court Justice Sonia Sotomayor, the final dinner's guest speaker. Associate Justice Sotomayor provided insights on the workings of the Supreme Court, working with her fellow justices, their willingness to work together and maintaining mutual respect—even when working on the most challenging of cases, often holding opposing legal views and opinions.

At the State Level:

The AAUW-California board has modified their mission statement as follows:

AAUW-California facilitates California branches in meeting the vision and mission of AAUW by providing programs, education, and resources.

The change in the mission statement will more clearly capture the purpose and work of AAUW-California, which is to support the branches. The new mission will guide the California board and state committees in their planning, much of which took place last month at the July Leadership Day in Sacramento.

GWA-AAUW looks forward to the continued support of both the national and state AAUW umbrella organizations in assisting our Branch in reaching our local policy goals.

What is the AAUW Fund? The beginning of the year is a good time to explain this important part of AAUW to new members and “old timers” alike. AAUW is a national organization to which our local Branch belongs. Its general fund provides unrestricted gifts which are used where and when they are most needed. Long-time members will remember the time when it used to be called “EF” or the “Educational Foundation” which basically funded our fellowship program. Now it has a broader use to support our mission-based programs and advocacy efforts.

It includes such programs such as Tech Savvy, Start Smart and Work Smart, Elect Her, the Legal Advocacy Fund, the National Conference for College Women Student Leaders (NCCWSL) and the National Convention, as well as the fellowship program that supports women studying for advanced degrees, as well as those applying for local grants. Information about these projects is given at our national website: aauw.org. Future Branch newsletter articles will highlight some of these programs.

At the same time our GWA-AAUW Branch has its own fundraising system, handled through the Myra Long Scholarship Fund, which funds such important local activities as Tech Trek, the Math Science Conference, and Local Scholarships.

The AAUW Fund is supported by our local membership contribution of \$2.00 each as part of our dues structure. This is only a small amount so we encourage our members to make individual tax-deductible contributions. You will be hearing more about that! And, in the past additional money has been donated from the profits of the Christmas boutique.

We hope you will read more on the website about the projects that are funded and will choose to make a contribution before the end of the year in order to support our national organization.

2017 Non-Event Fundraiser Honor Roll

Thank you, one and all! Our 2017 non-event fundraiser was a phenomenal success. We are grateful to all of you who gave so generously. We received \$11,145 from 75 donors. Donations ranged from \$10 to \$2,550. All of the proceeds helped to support our Local Scholarship, Math/Science and Tech Trek programs. We (1) awarded \$8,000 in scholarships to three women graduating from Rio Hondo Community College to help them continue their educations at Cal State Los Angeles, Cal State San Bernardino and Whittier College, (2) hosted 340 eighth grade girls from 27 middle schools at our 24th annual Math/Science Conference and (3) awarded scholarships to twelve eighth grades girls from three middle schools to attend the week-long Tech Trek Camp at Whittier College. Thank you for helping us continue this important work.

Greetings! As we began our new fiscal year on July 1, I am reaching out to each of you to share with you how our Branch did in the year just ended.

I am happy to report that we ended the year with a small surplus. We achieved this surplus by several means. First, our December Boutique fundraiser brought in a profit after paying the associated expenses and contributing \$500 to AAUW FUND in Washington DC. Second, your dues make a difference in keeping our Branch healthy and vital. Finally, our expenses for the year were less than what we thought we would spend when the year began.

The money that we all have contributed has gone to many worthy causes -- AAUW Fund, Las Distinguidas, and our Branch President attending the National AAUW Convention to name a few. Modern Trends in Literature

Our first meeting is Thursday, September 28, 7 P.M., at the home of Carol Shupek. She will also provide refreshments. The book for September is *Killers of the Flower Moon*, by David Grann. Gen'nel Walters will review.

From New Yorker staff writer David Grann, #1 New York Times best-selling author of *The Lost City of Z*, comes a twisting, haunting true-life murder mystery about one of the most monstrous crimes in American history. In the 1920s, the richest people per capita in the world were members of the Osage Indian nation in Oklahoma. After oil was discovered beneath their land, they rode in chauffeured automobiles, built mansions, and sent their children to study in Europe. Then, one by one, the Osage began to be killed off. The family of an Osage woman, Mollie Burkhart, became a prime target. Her relatives were shot and poisoned. It was just the beginning, as more and more members of the tribe began to die under mysterious circumstances.

In this last remnant of the Wild West—where oilmen like J. P. Getty made their fortunes and where desperadoes like Al Spencer, the “Phantom Terror,” roamed—many of those who dared to investigate the killings were themselves murdered. As the death toll climbed to more than twenty-four, the FBI took up the case. It was one of the organization’s first major homicide investigations, and the bureau badly bungled the case. In desperation, the young director, J. Edgar Hoover, turned to a former Texas Ranger named Tom White to unravel the mystery. White put together an undercover team, including one of the only American Indian agents in the bureau. The agents infiltrated the region, struggling to adopt the latest techniques of detection. Together with the Osage they began to expose one of the most chilling conspiracies in American history.

In *Killers of the Flower Moon*, David Grann revisits a shocking series of crimes in which dozens of people were murdered in cold blood. Based on years of research and startling new evidence, the book is a masterpiece of narrative nonfiction, as each step in the investigation reveals a series of sinister secrets and reversals. But more than that, it is a searing indictment of the callousness and prejudice toward American Indians that allowed the murderers to operate with impunity for so long. *Killers of the Flower Moon* is utterly compelling, but also emotionally devastating.

MORNING BOOK

We are starting the year off by reading *Missing, Presumed* by Susie Steiner. The author, a former journalist, shows a diverse crew of Brits coming to terms with both a murder and their own imperfect lives. Unhappy at midlife, Detective Sergeant Manon Bradshaw of the Cambridgeshire Major Incident Team faces down a complicated case involving an upper-class family and a lower-class young man in a novel that's audaciously full of real women's voices.

You might come to *Missing, Presumed* for the police procedural; you'll stay for the layered, authentic characters. Described in an NPR review as a "cozy noir" that "shows how women lose in a male centric society."

In a land of saffron sunsets and blazing summer heat, an Englishwoman has been found dead, her wrists slit, her body floating in a bathtub of blood and water. But is it suicide or murder? The case falls to Scotland Yard inspector Joe Sandilands, who survived the horror of the Western Front and has endured six sultry months in English-ruled Calcutta. Sandilands is ordered to investigate, and soon discovers that there have been other mysterious deaths, harkening sinister ties to the present case. Now, as the sovereignty of Britain is in decline and an insurgent India is on the rise, Sandilands must navigate the treacherous corridors of political decorum to bring a cunning killer to justice...knowing the next victim is already marked to die.

Sharon attended the invitational signing event as a representative of the Lutheran Office of Public Policy-CA (LOPP). Many leaders of the state government were in attendance and gave brief speeches before the signing.
