## **PUBLIC POLICY**

#### DREAMS DESTROYED

If you are shaking your head and wondering just what kind of a country, a society, we have become, you are not alone. The vast majority of us, regardless of political persuasion, do not subscribe to a philosophy that punishes children for the actions of their parents. Nor do most of us believe that functioning, tax-paying members of our society, students striving to be that and especially young people who are serving or have served in the military should have their lives upended.

AAUW's position on the president's rescinding of the Deferred Action for Childhood Arrivals (DACA) is clear and unequivocal: "The President's decision to end DACA is both morally and fiscally irresponsible and Congress must take action. Tell Congress we must protect Dreamers and pass the Dream Act today!"

AAUW is joined in its opposition to rescinding DACA by myriad government and business leaders from across the political spectrum – from Paul Ryan and John McCain to just about every Democratic legislator and from industry leaders such as Tim Cook, CEO of Apple, Satya Nadella, CEO of Microsoft and J.P. Morgan Chase CEO, Jamie Dimon who stated: **"When people come here to learn, work hard and give back to their communities, we should allow them to stay in the United States."** In fact, the president's two business industry councils disbanded in protest of the action.

The fix to this situation lies with Congress, and AAUW is urging members to call their congressional representatives and urge passage of The Dream Act, a bi-partisan, bicameral bill that would offer many, including DACA recipients, protection from deportation while allowing them to continue access to education or work and contribute to our society. Our higher education system and our economy are stronger because of the contributions of DACA recipients.

Visit the AAUW website, <u>http://www.aauw.org</u>, click on ISSUES and then on Take Action. The application will assist you in getting to the appropriate legislators. It is also perfectly fine to call key legislators in other states, such as the Speaker of the House, the Senate Majority Leaders or anyone you feel can have an influence.

These young people are our friends and neighbors, our colleagues and our own children's and grandchildren's friends and playmates. Please don't sit idly by while their lives are in turmoil and their futures endangered.



# AAUW FUND

Last year many local AAUW members became aware of the Aileen Rizo case that was supported by the Legal Advocacy Fund under the AAUW Fund. Some of our Branch members attended a luncheon at Cal Poly Pomona to hear the plaintiff and were extremely moved by the injustice she suffered. There has been a recent development which is described in the article below taken from the AAUW.Org website. Be sure to note the action taken on August 29, 2017, which is described at the end.

LAF Plaintiff Aileen Rizo

On April 27, 2017, the U.S. Court of Appeals for the Ninth Circuit handed down an unfavorable decision in Aileen Rizo's case. The court held that using prior salary alone to calculate current wages can be permissible under the Equal Pay Act as a "factor other than sex" if the defendant shows that its use of prior salary was reasonable and effectuated a business policy.

Rizo argued that using prior salary alone to calculate current wages perpetuates existing pay disparities and undermines the legislative intent of the Equal Pay Act, which is to address pay inequity based on sex.

This unfavorable ruling magnified the need for strong state and federal legislation that eliminates the practice of using prior salary alone to calculate current wages.

The case was remanded back to district court to determine if the business reasons presented by the defendant are reasonable given their stated purpose. AAUW joined an <u>amicus brief</u> in support of Rizo's petition for rehearing en banc — in front of all the judges of a court rather than only a selected panel — and urged the Ninth Circuit to reconsider. On August 29, 2017, the Ninth Circuit granted a <u>petition</u> for rehearing en banc.

AAUW continues to support Rizo through our <u>legal case-support program</u> as her case moves through various stages of the judicial system. Despite the complexity of the judicial process, the policy behind the process is AAUW's focus. AAUW's paramount concern for Rizo and others is achieving pay equity.

### **Modern Trends in Literature**

Modern Trends will meet Thursday, October 26, 7 PM, at the home of Kristine Yeseta, who will also provide refreshments.

A Gentleman in Moscow, Towles: He can't leave his hotel. You won't want to. From the New York Times bestselling author of *Rules of Civility*—a transporting novel about a man who is ordered to spend the rest of his life inside a luxury hotel.

In 1922, Count Alexander Rostov is deemed an unrepentant aristocrat by a Bolshevik tribunal, and is sentenced to house arrest in the Metropol, a grand hotel across the street from the Kremlin. Rostov, an indomitable man of erudition and wit, has never worked a day in his life, and must now live in an attic room while some of the most tumultuous decades in Russian history are unfolding outside the hotel's doors. Unexpectedly, his reduced circumstances provide him entry into a much larger world of emotional discovery.

Brimming with humor, a glittering cast of characters, and one beautifully rendered scene after another, this singular novel casts a spell as it relates the count's endeavor to gain a deeper understanding of what it means to be a man of purpose.

[A Gentleman in Moscow] is laced with sparkling threads (they will tie up) and tokens (they will matter): special keys, secret compartments, gold coins, vials of coveted liquid, old-fashioned pistols, duels and scars, hidden assignations (discreet and smoky), stolen passports, a ruby necklace, mysterious letters on elegant hotel stationery... a luscious stage set, backdrop for a downright Casablanca-like drama." –The San Francisco Chronicle
