# **PUBLIC POLICY**

Because it is always helpful to be reminded of AAUW 's mission and purpose as it relates to its policy work, the following is AAUW's explanation of the organization's political work vs. partisanship individual preferences, particularly, during these very challenging times.

Our work has always been political but has never been partisan. Values influence our work, but what is the line between being political and being partisan? Political work can be characterized by shared values, working toward a common goal, and an end result that is best for the community as a whole. Put simply, being political is a way to influence legislation and regulation through government or public affairs, while partisan activities have a firm adherence to a party, faction, or person.

For example, AAUW believes **there is a gender pay gap** and that we should do something to address it. AAUW believes **sexual assault is a big problem on campuses** that undermines women's access to equal educational opportunities. These are political positions, but we work to solve them in a nonpartisan way. We'll work with any policy makers who share our goals — even if they differ with us on another facet of the AAUW Public Policy Priorities.

When members take advocacy actions **in the name of AAUW**, those actions must be political rather than partisan. Here are some things to keep in mind when determining if your actions are political or partisan:

DO

- Remain nonpartisan. Do not endorse candidates in partisan races.
- Work on issues guided by our values and mission, including taking positions on ballot initiatives that are in line with AAUW's Public Policy Priorities.
- Engage with candidates and elected officials from all major parties equally, making sure questions are phrased in a neutral manner.
- Encourage voter registration for everyone, regardless of his or her political persuasion.

#### DO NOT

- Expressly advocate for or endorse any particular partisan candidate.
- Encourage voter registration for a particular party.
- Share AAUW membership lists with campaigns or political parties.
- Fundraise for partisan candidates or coordinate any election activity with a campaign or political party.

Do's and Do Not's" relate only when actions are being taken in the name of AAUW and not your personal preferences or endorsements.

# AAUW FUND

There are many aspects to the AAUW Fund. Below is an account of the Eleanor Roosevelt Fund Award. This information was taken from the AAUW.org website.

Established in 1989, the Eleanor Roosevelt Fund Award honors an individual, project, organization, or institution for outstanding contributions to equality and education for women and girls. The award is given for a broad range of activities including classroom teaching, education and research, and legal and legislative work in equality for women and girls. While the award focuses on education, the recipient need not be an educator.

### 2017 Award Recipient

SurvJustice is a national nonprofit organization based in Washington, D.C., that increases the prospect of justice for all survivors through effective legal assistance. SurvJustice enforces victim rights and holds both perpetrators and enablers of sexual violence accountable in campus, criminal, and civil systems.

Founded in 2014 by Laura L. Dunn, it remains the only national organization that provides legal assistance to survivors in campus hearings across the United States. SurvJustice also provides policy advocacy and institutional training services to communities that seek to better prevent and address campus sexual violence. By working on these fronts, SurvJustice decreases the prevalence of campus sexual violence through the United States.



## **RESULTS of the AAUW CA INCORPORATION VOTE**

The statewide vote to return AAUW California to a public benefit corporation from its current status as a mutual benefit corporation **failed!** The results of the vote are:

Total AAUW California Membership: 11,907 Total votes cast: 3,160 Total "yes" votes: 3,134 Total "no" votes: 26

California corporate regulations require that all votes cast for a mutual benefit corporation to change its status to an entity such as a public benefit corporation must be unanimous. Since there were 26 "no" votes, the measure failed. One of the "no" votes was from a member of the GWA AAUW branch.

What is next? AAUW California's legal counsel has advised that the state board can call for a re-vote. The second vote will be scheduled after the Thanksgiving holiday. If a second vote fails, AAUW California will petition the Commissioner of the Securities Division of the Corporations Division of the California Secretary of State to change AAUW CA's status. If that appeal fails or is rejected, the only option is to dissolve the current corporation and re-form as a public benefit corporation.

As an affiliate of AAUW National, AAUW California must be aligned with AAUW as a public benefit corporation and **cannot remain** as a mutual benefit corporation. Fortunately, when our GWA AAUW branch incorporated in the State of California in 2011, we did so as a public benefit corporation.

How much has this cost? Since 2016, AAUW California has invested more than \$10,000 and more than 250 volunteer hours to resolve this issue. If the next vote fails, the appeal process also will be costly.

We on the GWA AAUW branch board encourage you to affirm AAUW CA's corporate status by voting "yes" during the re-vote. If you have any questions, please call a member of the GWA AAUW board to discuss the issues or write to the AAUW CA Governance Committee at governance@aauw-ca.org.
